**PARENT OR GUARDIAN'S AGREEMENT TO PARTICIPATE,
RELEASE, WAIVER OF LIABILITY AND ASSUMPTION OF RISK
FOR PARTICIPANTS UNDER 18 YEARS OF AGE**

In consideration of the minor(s) identified below being permitted both to access the Range at HMAC's facility and to use the Range for authorized range shooting:

1. I am the parent or legal guardian of the minor(s) identified below.
2. I have read, understand and agree to the terms and conditions of this Agreement.
3. I understand and am aware that there that the use of archery equipment and/or participating in archery activities at the Range is inherently dangerous and entails known and unanticipated risks that could result in bodily injury, permanent disability, death, damage to property or injury to other persons. I further understand that the use of archery equipment has certain dangers that no amount of care, instruction or experience can eliminate.
4. I understand that the Range is to be used only for range shooting at paper stationary targets. I further understand that HMAC does not provide any archery equipment and does not provide any professional supervision on the Range, including for participants under 18 years of age.
5. I freely consent to the minor(s) identified below using the Range with full knowledge of the inherent risks, hazards and dangers involved, both known and unknown, and I choose fully to accept any and all risks of injury, death or damage, including those that may arise out of the negligence of other shooters, that might the minor(s) identified below might suffer or incur.
6. To the extent permitted by law, on behalf of the minor(s) identified below, I hereby release, waive, hold harmless, discharge and covenant not to sue HMAC from and against any and all loss, claims, injuries to property, personal injuries, death or other damages in any way connected to the participation in shooting at the Range by the minor(s) identified below, however caused and regardless of the manner in which such loss, damage, injury or death arises or is caused. THIS MEANS THAT NEITHER I NOR ANYONE ACTING ON MY BEHALF MAY PURSUE ANY CLAIM FOR DAMAGES AGAINST HMAC FOR ANY INJURIES OR DAMAGES SUFFERED AS A RESULT OF OR ARISING FROM PARTICIPATION IN SHOOTING AT THE RANGE BY THE MINOR(S) IDENTIFIED BELOW.
